- b. <u>Traffic control signage</u> battery needs changing on the traffic control system in Rectory Lane, Cllrs to try and obtain data from the system to log traffic speeds.

a. <u>Fencing on the recreation ground</u> – Council agreed the weather and ground conditions need to improve before the fencing can be installed.

2213 General Items for Discussion

- a. <u>Resilience group</u> and flood issues: formal investigation report is available: https://www.leicestershire.gov.uk/sites/default/files/field/pdf/2021/11/9/appleby-magna-final-flood-report-november-2021.pdf
 - A flood meeting had been held with approximately 20 attendees notes from the meeting may be obtained from Cllr Sue Mitchell. Council agreed to lead a resilience group (for all risk areas including local disasters etc) but this needs input from residents too.
 - Council will send an email/letter to Severn Trent requesting a formal status summary report, with illustrative maps and full explanations to include a timeline showing past and future work deemed necessary.
- b. <u>Community Group</u> update plans to commemorate the Queen's platinum Jubilee for 2/3 June 2022 are under way, village fun day to be held on the 5 June 2022. Council discussed progress to date and approved proposals. Public Liability insurance must be held by those running various initiatives. At least one first responder will be required.
- c. <u>Small shed for general storage</u> grant being applied for an 8' x '6' metal shed is required.
- d. <u>Snow Warden</u> scheme LCC are running the scheme and offering £8.91 per hour equipment will be provided.
- e. <u>Flood Warden</u> is required this is a voluntary position.
- f. Council received a query re a mobile post office van service in the village Councillors agreed this is a good idea Cllrs to ask the Crown Pub if they would allow the van to park in their car park.
- g. <u>Parish News-sheet</u> this has been distributed to every household in the Parish excellent feedback has been received.
- h. <u>NWLDC will provide</u> a bench or a tree in each Parish to cover district wide Covid commemoration Council will request a bench to be situated within the play area.
- **Risk assessment** for all relevant areas to include flood risk & play area (at the time of inspection play area Rospa report has shown a few areas of basic concern, these are being rectified). Next budget to include some new equipment for the play area.
